The Contracts Committee meeting convened at 3:35 p.m. on August 20, 2019.

The meeting was called to Order and legal certification of compliance with Florida's Public Meetings Law was given by Frank Rainer, Senior Vice President and General Counsel. Mr. Rainer indicated that the meeting materials were not posted based on assertion of confidentiality.

The following agenda items were discussed:

#### 1. Board Approved Contracts:

a. New Physician Employment Agreement between Syndi Seinfeld, D.O., Medical Director, Epilepsy Program-Pediatric Neurology Services and South Broward Hospital District

The Committee reviewed the new Physician Employment Agreement between the South Broward Hospital District and Syndi Seinfeld, D.O., Medical Director, Epilepsy Program-Pediatric Neurology Services.

Dr. Seinfeld received a Bachelor of Science from the College of New Jersey, Ewing, NJ (2001), a Doctor of Osteopathic Medicine degree from New York College of Osteopathic Medicine (NYCOM), Old Westbury, NY (2005) and a Master of Clinical and Translational Science from Virginia Commonwealth University, Richmond, VA (2014). She completed a General Internship at Good Samaritan Medical Center, West Islip, NY (2006), a Pediatric Residency at Virginia Commonwealth University Hospital, Richmond, VA (2008), a Child Neurology Fellowship at Virginia Commonwealth University Hospital, Richmond, VA (2011), and a Neurophysiology Fellowship, Virginia Commonwealth University Hospital, Richmond, VA (2012). Dr. Seinfeld is certified by the American Board of Psychiatry and Neurology, Epilepsy.

Dr. Seinfeld will be responsible for providing Pediatric Neurology Services, including epilepsy and intraoperative neuro-monitoring, consistent with the clinical scope of her privileges. She will provide medical care and treatment to all patients who require the services of a Pediatric Neurologist and Epilepsy Specialist. She shall provide such services assuring that patient care is delivered in a manner

which results in safe, high-quality care, as measured by clinical outcomes and patient satisfaction. Dr. Seinfeld may also be required to perform other medical administrative services. Under this Employment Agreement, she will be required to perform such services at any Hospital District location.

The details of Dr. Seinfeld's compensation package were discussed. The Committee noted that there is no benchmark for Pediatric Neurology with a subspecialty in Epilepsy including skills in intraoperative neuro-monitoring procedures, thus, salary was determined based on review by outside independent appraisers.

The Employment Agreement shall be effective December 16, 2019, and shall remain in effect for three (3) years. The Employment Agreement may be terminated for cause as stipulated in the Agreement or by either party, without cause, by giving the other party at least 90 days prior written notice.

During the Term of the Agreement and for a period of two years following the Term, physician shall not, without the prior written consent of the Hospital District, provide services within the geographic boundaries of the Restricted Area of Broward County plus five (5) miles.

Following further discussion:

The Contracts Committee recommends to the Board of Commissioners approval of the new Physician Employment Agreement with Syndi Seinfeld, D.O., Medical Director, Epilepsy Program-Pediatric Neurology Services.

 Renewal Physician Employment Agreement between Christopher R. Seaver, M.D., Adult General Surgery and Associate Residency Program Director General Surgery Residency Program and South Broward Hospital District

The Committee reviewed the renewal Physician Employment Agreement between the South Broward Hospital District and Christopher R. Seaver, M.D., Adult General Surgery and Associate Residency Program Director General Surgery Residency Program.

Dr. Seaver received a B.S. Degree in 1996 from Providence College, Providence, RI; an M.S. Degree in 1998 from Georgetown University, Washington, DC; and his M.D. Degree in 2003 from the University of Texas, San Antonio, TX. He completed a General Surgery Residency (2003 – 2008) at Jackson Memorial Hospital, Miami, FL and a Vascular Surgery Fellowship (2008 – 2009) at the University of Florida, Gainesville, FL. Dr. Seaver practiced in St. Croix, USVI (2010 – 2013) and served as Chief, Department of Surgery (2012 – 2013) and President-Elect of the Medical Staff (2013) at Juan F. Luis Hospital and Medical Center. Dr. Seaver served as Attending General Surgeon at Holy Cross Hospital, Ft. Lauderdale, FL. (2013-2016). He has been employed by MHS since 2016. Dr. Seaver is board-certified in General Surgery.

Dr. Seaver will be responsible for providing Adult General Surgery Services consistent with the clinical scope of his privileges. He will provide medical care and treatment to all patients who require the services of an Adult General Surgeon. He shall provide such services assuring that patient care is delivered in a manner which results in safe, high-quality care, as measured by clinical outcomes and patient satisfaction. Dr. Seaver may also be required to perform other surgical or medical

administrative services. Under this Employment Agreement, he will be required to perform such services at any Hospital District location.

The details of Dr. Seaver's compensation package were discussed. The Committee noted that that Dr. Seaver's salary was evaluated based upon the 2018 – 2019 Physician Salary Matrix for General Surgery.

The Employment Agreement shall be effective September 1, 2019, and shall remain in effect for five (5) years. The Employment Agreement may be terminated for cause as stipulated in the Agreement or by either party, without cause, by giving the other party at least 90 days prior written notice.

During the Term of the Agreement and for a period of one year following the Term, physician shall not, without the prior written consent of the Hospital District, provide services within the geographic boundaries of the Restricted Area of Broward County plus five (5) miles with the exception that the Physician shall be able to return to employment at Holy Cross Hospital located at 4725 N. Federal Highway, Ft. Lauderdale, FL 33308.

The Contracts Committee recommends to the Board of Commissioners approval of the renewal Physician Employment Agreement with Christopher R. Seaver, M.D., Adult General Surgery and Associate Residency Program Director General Surgery Residency Program

c. Renewal Physician Employment Agreement between Carrie Ann Laituri, M.D., Pediatric General Surgery and South Broward Hospital District

The Committee reviewed the renewal Physician Employment Agreement between the South Broward Hospital District and Carrie Ann Laituri, M.D., Pediatric General Surgery.

Dr. Laituri received a B.S. Degree in 1999 from the University of Minnesota, Minneapolis, MN, and her M.D. Degree in 2006 at Ross University. She completed General Surgery Residencies at Orlando Regional Medical Center, Orlando, FL (2006 – 2009), and at the University of Kansas School of Medicine, Kansas City, KS (2010 – 2012). Dr. Laituri completed a Pediatric Surgery Fellowship (2012 – 2014) at Indiana University School of Medicine, Indianapolis, IN. She served as Assistant Professor of Surgery at University of South Florida Morsani College of Medicine, Tampa, FL, and practiced at Tampa General Hospital and Shriners Hospital for Children. (2014-2016). Dr. Laituri has been employed by MHS since 2016. She is board-certified in Surgery and Pediatric Surgery.

Dr. Laituri will be responsible for providing Pediatric General Surgery Services consistent with the clinical scope of her privileges. She will provide medical care and treatment to all patients who require the services of a Pediatric General Surgeon. She shall provide such services assuring that patient care is delivered in a manner which results in safe, high-quality care, as measured by clinical outcomes and patient satisfaction. Dr. Laituri may also be required to perform other surgical or medical administrative services. Under this employment agreement, she will be required to perform such services at any Hospital District location.

The details of Dr. Laituri's compensation package were discussed. The Committee noted that Dr. Laituri's salary was evaluated based upon the 2018 – 2019 Physician Salary Matrix for Pediatric General Surgery.

The Employment Agreement shall be effective November 14, 2019, and shall remain in effect for two (2) years. The Employment Agreement may be terminated for cause as stipulated in the Agreement or by either party, without cause, by giving the other party at least 90 days prior written notice.

During the Term of the Agreement and for a period of one (1) year following the Term, physician shall not, without the prior written consent of the Hospital District, provide services within the geographic boundaries of the Restricted Area of Broward County plus five (5) miles.

#### 1. SUBJECT: Construction Progress Report

#### 2. SUBJECT: Projects in Planning Report

The Committee reviewed the report. Mr. Schlemmer advised that six (6) projects were added since the Committee last met.

#### 3. SUBJECT: <u>Bid Openings</u>

a. Kitchen Equipment Replacement – Memorial Regional Hospital

Bids for the Kitchen Equipment Replacement project were opened on August 14, 2019, in the Executive Conference Room of the 3111 Stirling Road Building.

Bids from five, Board approved, pre-qualified construction contractors were received for the project. The low bidder was Gerrits Construction, Inc., in the amount of \$1,391,697. In order to account for any unforeseen conditions that may arise during the performance of the work, the Healthcare System will allocate \$210,000 of contingency dollars within the total project budget. These funds will be controlled and used solely by the Memorial Healthcare System. After review and discussion,

The Building Committee recommends to the Board of Commissioners acceptance of the lowest bidder, Gerrits Construction Inc., in the amount of \$1,391,697 for the Kitchen Equipment Replacement Project at Memorial Regional Hospital and allocate a \$210,000 contingency amount to be controlled by the Memorial Healthcare System

#### 4. SUBJECT: Other

Mr. Schlemmer updated the Committee on staff's progress in developing the Guaranteed Maximum Price (GMP) for the Joe DiMaggio Children's Hospital Expansion. He informed the Committee of the measures being prepared to ensure an appropriate package is presented to the Board.





### **Memorial Healthcare System - Executive Summary - July 2019**

- Inpatient Revenue was slightly above budget due to 2.1% higher patient days and 1.8% higher inpatient surgeries, partially offset by 6.0% fewer admissions
- Outpatient Revenue was above budget due to 3.4% higher observation discharges, 5.1% higher outpatient surgeries and 3.6% higher outpatient visits
- Net Revenue of \$186.8M was above budget of \$182.5M and Income from Operations of \$12.8M was above budget of \$8.6M
- Excess of Revenues Over Expenses was \$13.3M, including unrealized losses of \$2.1M, compared with a budget of \$10.7M














#### Memorial Healthcare System - Consolidated Volumes and Payor Mix - July 2019
